City Manager Cunningham asked Champion E.M.S. representatives if the City could sign the contract with and agreement clause that if the legal review showed that memberships could be offered to the Overton citizens that the contract would be amended.

Champion E.M.S. representative Stan Holden stated that the Board had agreed to extend the current contract through January 2015 for the legal department to review the City's proposed changes.

City Manager Cunningham requested a letter stating that Champion E.M.S. had extended the City of Overton's contract.

Champion E.M.S. representative Stan Holden agreed to provide a letter granting the 30 day contract extension.

ORDINANCE # 2014-12-18A: AN ORDINANCE AMENDING ORDINANCE # 2014-07-29A WHICH ESTABLISHED BY REFERENCE \$ 35.70 PERSONNEL, RULES AND POLICIES (APPENDIX 5) WHICH SHALL NOW BECOME \$ 35.70 PERSONNEL POLICIES AND PROCEDURES (APPENDIX C); PROVIDING A SEVERABILITY CLAUSE, AN EFFECTIVE DATE AND PROVIDING FOR PUBLICATION.

- WHEREAS, it is incumbent upon the City to maintain policies and procedures governing personnel administration that provide a framework for fair and equal treatment of its employees, complies with all related federal, state and local legal requirements related to employment law; and
- WHEREAS, the original version of personnel policies and procedures are in need of revision and extension of application as they appeared in the original form; and
- WHEREAS, Attachment A to this ordinance provides a more complete and up-to-date set of policies and procedures governing issues related to personeel management and administration;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OVERTON, TEXAS:

SECTION 1: THAT the Chapter 35.70 of the Overton Code of Ordinances is hereby amended and upon adoption of this ordinance, shall read as follows:

§ 35.70: Adoption of Personnel Policies and Procedures

Personnel policies and procedures for the City of Overton are hereby adopted as set forth in the document entitled Personnel Rules and Regulations and included in this Code as Appendix C.

SECTION 2: Overton Code of Ordinances - Appendix C

Appendix C as specified above refers to Attachment A of this Ordinance.

SECTION 3: SEVERABILITY

It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this ordinance are severable and, if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional or otherwise

invalid by the final judgment or decree of any court of competent jurisdiction, such invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the city council without the incorporation in this ordinance of any such invalid phrase, clause, sentence, paragraph or section.

SECTION 4: PUBLICATION

The City Secretary is hereby authorized and directed to cause the publication of the descriptive caption and penalty clauses of this Ordinance as an alternative method of publication provided by law.

SECTION 5: EFFECTIVE DATE

This Ordinance shall be effective January 10th, 2015.

CHAPTER 87: COMMUNITY CENTER RULES & REGULATIONS

AN ORDINANCE ADDING CHAPTER 87 TO THE CITY OF OVERTON CODE OF ORDINANCES; ESTABLISHING RULES AND REGULATIONS FOR THE RENTAL OF THE OVERTON COMMUNITY CENTER BUILDING AND PROVIDING A SEVERABLITY CLAUSE AND DECLARING A PENALTY FOR VIOLATIONS OF CERTAIN RULES; REGULATIONS PROVIDED WITHIN; PROVIDING FOR PUBLICATION AND AN EFFECTIVE DATE.

WHEREAS, it is the intent of the City Council of the City of Overton to protect the public health, safety, and welfare, of the citizens of Overton, Texas; and

WHEREAS, the establishment of rules and regulations for the rental and use of the publicly owned Community Center facility is in the best interest in the protection of this public facility; and

WHEREAS, a goal of this ordinance is to establish such rules and regulations for the rental and use of said Community Center; and

WHEREAS, it is necessary to protect the rights of all citizens who, for legitimate reasons, for the continued preservation and future use of this public facility; and

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OVERTON, TEXAS:

THAT the Code of Ordinances, City of Overton, Texas, is hereby amended by adding CHAPTER 87 entitled "COMMUNITY CENTER RULES & REGULATIONS", to read as follows:

SEC. 87.01 PURPOSE:

The purpose of the Overton Community Center Rules & Regulations is to protect public health, safety, welfare and publicly owned facility.

SEC. 87.02 DEFINITIONS.

<u>Alcoholic Beverage</u>. Means alcohol, or any beverage containing more than one-half of one percent of alcohol by volume, which is capable of use for beverage purposes, either alone or when diluted.

<u>Beer.</u> Means a malt beverage containing one-half of one percent or more of alcohol by volume and not more than four percent of alcohol by weight

<u>City Hall Personnel</u>. A representative of the City of Overton, specifically the Utility Billing Clerk, Finance Director or City Secretary.

<u>Community Center.</u> A publicly owned facility located at 505 Meadowbrook Drive, Overton, Texas.

Lessee. A person or organization that seeks to lease / rent the Overton Community Center

<u>Lease.</u> The agreement to pay a set fee, as set forth in Appendix A – Schedule of Fees, for the purpose utilization of the Overton Community Center.

<u>Security Deposit.</u> A set fee, as set forth in Appendix A – Schedule of Fees, for the purpose of securing a said rental date and insuring that the said Community Center building, equipment and grounds shall be left in the same clean condition as when it was rented.

Sponsor. A responsible adult given the authority by the Lessee to supervise and be a representative of the Lessee in insuring the public facility is protected from damage to the grounds, equipment and building.

<u>Wine and Vinous Liquor.</u> Means the product obtained from the alcoholic fermentation of juice of sound ripe grapes, fruits, berries, or honey, and includes wine coolers.

SEC. 87.03 RULES & REGULATIONS.

- 1. Lease Agreement application form must be submitted to City Hall personnel in person by the individual leasing the building.
- 2. The lease is not considered in effect until the Security Deposit has been paid in full.
- Reservations will be taken in order of reservation requested. Roll over reservations/ deposits are not allowed (lessee must complete a new lease agreement application for each reservation).
- Lessee must be a responsible adult, at least twenty-one (21) years of age, and must submit payment in full and provide a signed complete Lease Agreement application before the key will be issued.
- 5. Lessee must disclose on said Lease Agreement application whether there will be any alcoholic beverages present, allowed, provided or served at the Community Center during the rental time. If there will the consumption of any alcoholic beverage at said event; it is the lessees responsibility to provide the following:
 - a. Licensed commissioned police officer to provide security before, during, and after the event.
 - b. T.A.B.C. Certified Server must be in charge of mixed beverage service
- Building key must be returned to City Hall with Community Center Clean Up List form signed as soon as possible following use of the building. (Key may be placed in the drop box located to the right of City Hall front door.)
- Lessee shall be held accountable for any damage done to the building, equipment and/or grounds for reasonable replacement/repair costs.
- Lessee agrees to leave the building, equipment and grounds in clean and orderly condition.
- Lessee shall be held responsible for the decent and orderly conduct of all guests or
 persons allowed access to the premises during the lease. Failure to do so as agreed will
 result in forfeiture of the security deposit made by the lessee.
- 10. Sponsors of parties for minors must be present at all times. It is required that there is at least one sponsor for each ten (10) minors.
- 11. The City of Overton has the right to terminate the lease for the need or use of any City sponsored event and/or damage to the building or failure to leave the premises clean in accordance with the Community Center Clean Up List.

- 12. Lessee and sponsors agree to see that the following rules are observed, and that all property of the City of Overton is protected against loss or breakage and left in a clean and orderly manner. Kitchen, stove, oven, restrooms, tables, chairs are to be cleaned and put away after each event.
 - a. Any decorations used must be attached only using tape and must be removed as per the posted Community Center Clean Up List. Nails, staples or anything that leaves holes in the walls or woodwork is strictly prohibited; the security deposit shall be forfeited if nail holes, staples or tape remnants are found.
 - b. Moving of any appliances is strictly prohibited and will result in forfeiture of security deposit and loss of future use of the building.
 - c. Smoking is strictly prohibited inside of the Community Center
- 13. The City of Overton shall furnish only that which is at hand. Any service other than keeping the building clean will have to be furnished by the lessee.
- 14. Security Deposit fee shall be forfeited if reservation is not cancelled at least seven (7) calendar days prior to the reservation date. Failure to cancel reservation at least forty-eight (48) hours prior to scheduled event shall result in the loss of the Security Deposit and Rental Fee. Cancellations will be accepted by phoning City Hall personnel. Unless contact is made, forfeiture of fees shall be assessed.
- 15. The Community Center is furnished for your pleasure and benefit, and charges are made for the actual maintenance and upkeep of the building. Please be courteous and preserve it for the use of others in the future.

SEC. 87.04 OFFENSES.

- a. A lessee commits and offense if he allows, provides or serves any alcoholic beverage without having properly notified the City that alcoholic beverages would be present at the Community Center during the said rental dates and/or times on the lease agreement.
- b. A lessee commits and offense if he has denoted that alcoholic beverages would be present at the Community Center during the said rental dates and/or times on the lease agreement; however, fails to hire the services of a commissioned off-duty law enforcement officer to provide security for at least one (1) hour prior to, during the duration of said event, and up to (1) hour after said event as stated on the lease agreement.
- c. A lessee commits an offense if he has denoted that mixed beverages would be present and/or served at the Community Center during the said rental dates and/or times as denoted on the lease agreement; however, fails to hire the services of a T.A.B.C. Certified Server.

SEC. 87.05 ENFORCEMENT.

All Community Center events are subject to drive by and on-site inspections at any time during event by the Overton Police Department or an authorized representative of the City of Overton. A police officer, upon finding a violation of Section 87.04 (a), (b) and/or (c), shall ascertain the name and address of the lessee and may issue a citation to the lessee.

SEC. 87.06 PENALTIES.

Any person who violates Section 87.04 (a), (b) and/or (c), of this section shall loose said security deposit and be punishable by a fine as provided for in the current City of Overton – Appendix B – Schedule of Fines.

SEC. 87.07 SEVERABILITY.

It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this ordinance are severable and, if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional or otherwise invalid by the final judgment or decree of any court of competent jurisdiction, such invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the city council without the incorporation in this ordinance of any such invalid phrase, clause, sentence, paragraph or section.

SEC. 87.08 PUBLICATION.

The City Secretary is hereby authorized and directed to cause the publication of the descriptive caption and penalty clauses of this Ordinance as an alternative method of publication provided by law.

SEC. 87.09 EFFECTIVE DATE.

This Ordinance shall be effective immediately upon its passage and approval.

AN ORDINANCE ADDING AN APPENDIX B TO THE CITY OF OVERTON CODE OF ORDINANCES, HEREAFTER TO BE KNOWN AS APPENDIX B, CITY OF OVERTON – SCHEDULE OF FINES, AMENDING ANY CURRENT PENALTIES AS SET FORTH IN ANY INDIVIDUAL ORDINANCE LOCATED IN THE CODE OF ORDINANCES; PROVIDING FOR PUBLICATION; A SEVERABLITY CLAUSE AND AN EFFECTIVE DATE

WHEREAS, the City of Overton desires to summarize and set forth a schedule of fines and penalties for each ordinance and law requiring such in one central location of the City of Overton Code of Ordinances:

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OVERTON, TEXAS;

SECTION 1. ADOPTION OF APPENDIX B - SCHEDULE OF FINES

That the provisions, policies, fines, penalties and violations of ordinances and laws of the City of Overton are hereby amended and revised as set out in Appendix B the City of Overton, Schedule of Fines hereto as Exhibit "A" and made a part hereof for all purposes.

SECTION 2. REPEAL OF ORDINANCES

That all ordinances or parts of ordinances in conflict herewith are, and the same are hereby, repealed to the extent of such conflict.

SECTION 3. VALIDITY

If for any reason any section, paragraph, subdivision, clause, phrase, word or provision of this ordinance shall be held to be invalid and unconstitutional by final judgment of a court of competent jurisdiction, it shall not affect any other section, paragraph, subdivision, clause, phrase, word or provision of this ordinance, for it is the definite intent of this City Council that every section, paragraph, subdivision, clause, phrase, word or provision hereof be given full force and effect for its purpose.

SECTION 4. CONFLICTS

That all ordinance fee, penalties or fines in conflict herewith, are to the extent of such conflict, hereby repealed.

SECTION 5. PUBLICATION

The City Secretary is hereby authorized and directed to cause the publication of the descriptive caption and penalty clauses of this Ordinance as an alternative method of publication provided by law.

SECTION 6. EFFECTIVE DATE

This Ordinance shall be effective immediately upon its passage and approval.
