IV. NEW BUSINESS (CONSIDER AND/OR ACTION)

1. PRESENT AND DISCUSS PROPOSED 2014 MEETING SCHEDULE FOR THE CITY COUNCIL AND THE PLANNING AND ZONING COMMISSION.

City Manager Cunningham presented a revised calendar and a proposed plan of action to review and adopt the Annual Budget, Code of Ordinances, Fee Schedule, Manufactured Home Ordinance, Zoning Ordinance and Subdivision Ordinance.

City Manager Cunningham presented cover Ordinance Number 2014-07-29A for council review stating that this ordinance would re-adopt the 2002 version of the Code of Ordinance as shown in minutes of July 18, 2002 where council intended to adopt the current ordinances in effect; however, that signed ordinance has not been found.
