- I. <u>CALL TO ORDER</u> Mayor Evans called the meeting to order at 7:00 pm
 - 1. Invocation was given by Councilman Posey.
 - 2. Pledge of Allegiance was led by Councilman Clark.

V. CONSENT AGENDA

Mayor Evans introduced the Consent Agenda items

- 1. City Council to review, make possible corrections and approve minutes of:
 - a. Special Called Workshop of the City Council held on July 20, 2017.
 - b. Regular Called Meeting of the City Council held on July 20, 2017.

Councilman Posey made a motion to approve Consent Agenda as submitted.

Councilman Williams seconded the motion.

- 1. Present revised meeting schedule for the City Council as updated August 14, 2017.
 - a. Mayor to receive request, if any, for leave of absence from any Council Member from future meetings.

City Manager Cunningham presented the meeting calendar for September 2017. The September regular called meetings for OEDC and OMDD have been cancelled.

No requests for excused absences received

- 2. City Council to hear and discuss an update of the following pending issues:
 - a. Emergency Services District workshops.

City Manager Cunningham stated that the workshop discussions with the existing Overton Fire Department Volunteers would resume in November. Cunningham recommended Council making a decision on how to proceed in April/May 2018.

b. Dangerous Structures Ordinance revisions.

City Manager Cunningham stated that since City Attorney Thompson had made recommendations for several revisions to the proposed Ordinance amendment, staff would work on the revisions and have this on the Agenda for the October Council Meeting.

c. Removal of Cemetery Benches deadline August 18, 2017.

City Secretary Gafford presented the current listing of benches that had not been removed and which plot owners had installed bench pads. Gafford asked for direction as to whether more time should be allotted or should staff proceed with the bench removals.

Mayor Pro Tem Cox stated that he felt that staff should proceed with bench removal of all plot owners who had not removed or complied with the Cemetery Rules. Council agreed and Mayor Evans directed staff to remove the remaining benches from the cemetery.

d. FY 2017-18 Budget Calendar revised.

City Manager Cunningham presented a revised calendar for Council review for upcoming meetings for the adoption of the FY 2017-18 Budget and Tax Rates.

e. Report on gas leak and electrical line damaged that was reported behind Texas Bank & Trust in Overton August 9th and August 11th.

City Manager Cunningham informed Council that staff had followed all 8-1-1 procedures in having all utility lines marked prior to digging and staff was told by CenterPoint Energy that the gas line that was cut was a dead line. The electric line was not marked and Oncor was not aware that the line existed.

City Manager Cunningham gave a power point presentation covering Items VII.1 & VII.2 regarding the proposed Tax Rates for the City of Overton O & M, Debt and Cemetery to support the FY 2017-18 Budget. Cunningham proposed that the two Public Hearing dates for the tax rates be set for Thursday, August 31, 2017 and Thursday, September 7, 2017. Cunningham also proposed Council set the Public Hearing for the FY 2017-2018 Annual Operating Budget for Thursday, September 7, 2017.

5. City Manager's Monthly Report

City Manager Cunningham mentioned the following items during his report:

 County to continue to repair the roads that were schedule for this year in next year's budget year. • TCEQ is requiring the refurbishing of the ground storage tanks at both Well # 5 & Well #7, estimated cost for both will be \$160,000. Staff had submitted a request to give the City an extension on the refurbishing until February 2018, but had not received a response as of yet.

Mayor Pro Tem Cox asked if staff would consider approaching OMDD for the removal of the Cohagen storage tank.

City Manager Cunningham stated that he would need to get a bid on the cost to remove the tank but agreed that this would be a good project to be funded by OMDD.

• The engineering pressure study conducted by SPI recommended the consideration of a new well which is estimated to cost \$1,000,000. Recommending that this be a part of the next year's budget items and possibly sell bonds for the building of the new well.

Councilman Posey asked if selling bonds would be an election issue.

City Manager Cunningham responded that the City would have to conduct Public Hearings on the intent to issue bonds; however, if the City does not receive a petition to conduct an election on whether the City should issue bonds or not, then the City would not have to conduct an election.
