

ORDINANCE NO. 2015-08-20A
ORDER OF SPECIAL ELECTION FOR

A special election is hereby ordered to be held on Tuesday, November 3, 2015 in the City of Overton, Texas for the purpose of voting on the following proposition as required by Article XVI, Section 20 of the Texas Constitution; Chapter 501, Texas Election Code; and Chapter 251, Texas Alcoholic Beverage Code:


