## **RESOLUTION NO. 2015-03-19C**

A RESOLUTION OF THE CITY OF OVERTON, TEXAS, REPEALING RESOLUTION NO. 06-02-79, "DESIGNATING THE PLACE OF ALL MUNICIPAL ELECITIONS AND POLLING PLACES" AS THE CITY OF OVERTON COMMUNITY CENTER, 505 MEADOWBROOK DR., AND DESIGNATING THE OFFICIAL POLLING PLACE OF ALL FUTURE MUNICIPAL ELECTIONS SHALL BE OVERTON CITY HALL, COUNCIL CHAMBERS, 1200 S. COMMERCE ST., FOR THE 2015 MAY UNIFORM ELECTION SCHEDULED FOR MAY 9, 2015 AND ALL MAY UNIFORM ELECTIONS DATES IN THE FUTURE.

**WHEREAS,** The City of Overton previously designated the Overton Community Center, 505 Meadowbrook Dr., Overton, Texas as the official polling place for all elections held within the City of Overton; and

**WHEREAS**, the Overton Community Center has served as the official polling place since being designated by Resolution No. 06-02-79, on June 19, 1979; and

WHEREAS, The City Council of the City Overton believes it is in the best interest of the Citizens of the City of Overton to change the official polling place location for the May Uniform Election scheduled for May 9, 2015 to Overton City Hall, City Council Chambers, 1200 S. Commerce St., Overton, Texas; and

**WHEREAS,** The City Council of the City Overton has decided to designate Overton City Hall, City Council Chambers, 1200 S. Commerce St., Overton, Texas as the official polling place for all future Municipal Elections held on May Uniform Election dates.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OVERTON, TEXAS, THAT:

Beginning with the next called election on May 9, 2015, Overton City Hall, City Council Chambers shall be designated as the official polling place of the City of Overton and will remain so for all elections held thereafter

## REGULAR CITY COUNCIL MEETING June 19, 1979

The Overton City Council met in regular session, Tuesday, June 19, 1979 at 7:00 p. m. at City Hall, Overton, Texas with the following present:

Councilman Ronnie D. Ritch was not present.

Councilman Richmond introduced Resolution No. 06-01-79, "Setting The Frequency Of Standing City Council Meetings And Designating The Location Of Such Meetings", that effective July 1, 1979 regular City Council meetings for the City of Overton, Texas will be held twice monthly at 7:00 p. m. on the second and fourth Tuesdays. Councilman Richmond's motion was seconded by Councilman Davis and the motion passed unanimously. Mayor Bridges responded by pointing out that because of the press of decisions which would result from drilling the new water well that it would probably be advantageous for this increase in the number of monthly Council meetings but the number of meetings could be cut back at any time it proved to be unnecessary for this number of monthly meetings.

Councilman Richmond moved that effective July 10, 1979, City Council meetings will be held at the City/County Community Center located on South Meadowbrook Drive in Overton, Texas. See Resolution No. 06-01-79.

Councilman Richmond introduced Resolution No. 06-02-79, "Designating The Place Of All Municipal Elections And Polling Places", that effective July 1, 1979 all elections and polling activities related to the business of the City of Overton, Texas will take place at the City/County Community Center and that the City/County Community Center is hereby designated the official polling place for the City of Overton, Texas. The motion was seconded by Councilman McLane and the motion carried unanimously.

Councilman McLane introduced Resolution No. 06-03-79, "Initiating A Comprehensive Reappraisal Of Taxable Property In The City Of Overton, Designating The Appraisal Firm, And The Date Reappraisal May Be Initiated". The motion was seconded by Councilman Cox. The Resolution was unanimously rejected. The Council instructed City Manager Larry G. Moser to revise the resolution for presentation at the Regular City Council Meeting to be held July 10, 1979 at 7:00 p.m. setting the market value at 100%, with the rate to be determined, for the FY 1980-1981. The Council will set the rate per hundred to apply in order to increase ad valorem taxes sufficiently to cover expenditures in the General Fund to eliminate the over-draft status of the City.

City Councilman Cox introduced Resolution No. 06-04-79, "Setting An Auction Date For Surplus Property", that the date of July 24, 1979 be set aside as the date to receive sealed bids for the purpose of the items listed as follows:
