A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OVERTON, TEXAS TO APPROVE CONSTRUCTION AND IMPROVEMENTS FOR SMITH COUNTY APPRAISAL DISTRICT PROPERTY.

WHEREAS, § 6.051, TEX. PROPERTY TAX CODE authorizes the Board of Directors of an appraisal district to purchase or lease real property, construct or renovate a building or other improvements as necessary to establish and operate the appraisal office; and

WHEREAS, the appraisal district received approval from the taxing entities of Smith County in 2004 to construct additional square footage and site improvements with completion in 2005. A decision to purchase land to facilitate entrance and exit from Erwin St. was deferred; and

WHEREAS, as part of this proposal, the appraisal district will now seek to acquire the necessary land for an Erwin St. entrance and exit; and

WHEREAS, the Board of Directors of the Smith County Appraisal District desires to construct an addition of approximately 5,000 square feet to the property situated at 245 S.S.E. Loop 323 and whereas the building in its current condition needs some remodel consistent with current code and legal compliance; and

**WHEREAS**, the referenced provisions of the Texas Property Tax Code authorize the following action: and

**WHEREAS,** on March 19<sup>th</sup>, the Smith County Appraisal District passed a Resolution to construct additional improvements to the building located at 245 S.S.E. Loop 323.
