A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OVERTON, FORMALLY ACCEPTING RESPONSIBILITY AS TRUSTEE OF THE OVERTON MUNICIPAL CEMETERY WITH THE UNDERSTANDING THAT ACCEPTANCE OF SUCH RESPONSIBILITY OF THIS TRUST IS PERPETUAL.

WHEREAS, the City of Overton assumed responsibility for operation and maintenance of the Overton Municipal Cemetery from the Overton Cemetery Association on October 1, 2011; and

WHEREAS, § 713.002 of the Texas Health and Safety Code requires that a municipality’s governing body must adopt an ordinance or resolution stating the municipality’s willingness and intention to act as trustee with the understanding that such acceptance is perpetual; and


WHEREAS, the City Council of the City of Overton finds that accepting such responsibility is in the best interests of the citizens of the City of Overton.


