NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OVERTON, TEXAS:


SECTION 1: THAT the above canvass of the election results to be the same and is hereby approved.

SECTION 2: THAT the sale of all alcohol including mixed beverages is hereby declared legal within the city limits of the City of Overton subject to compliance with applicable


state and city regulations. The Resolution shall become effective immediately upon its passage and execution.


