CITY OF OVERTON RV PARK RULES AND REGULATIONS

1. Rent of RV space must be paid in advance. We accept cash, cashier checks, money orders and personal checks with proper identification.
2. Everyone is expected to keep their site clean. Please use the trash carts provided for your household trash which are located on the grounds.
3. Quiet time is 10PM to 7AM. Anyone considered a nuisance will not be tolerated, to include loud voices, sound equipment and disorderly conduct incidents. Please be considerate of others.
4. Dogs are to be contained within your space site or on a hand held leash anytime they are outside. Do not leave your pet unattended, especially if it tends to bark excessively or is disruptive to your neighbors. If you leave your pet inside your RV, leave a phone number where you can be contacted in case of an emergency.
5. No open flame fires are permitted anywhere in the RV park or city park.
6. Oil changes and other types of minor vehicle maintenance are not allowed on the city property.
7. We do not allow clotheslines to be set up. Automobiles, trucks nor RV's are allowed to be washed on city RV property. There is a car wash next to city hall.
8. Stay within your rented space. Do not place tables, chairs, tents, motorcycles, etc. on unrented space. Please place all excess television cable, electrical wires, sewer hose, and extension cords next to or under your RV. We are not responsible for damage to these items during mowing season. Do not hook up to utilities in the space next to yours unless you are willing to pay for a second space.
9. Damage or destruction of city property shall be paid by the responsible party. The city is not responsible for loss or damage of personal property caused by fire, theft, or accident.
10. If there are any problems or damage at your site, please inform us immediately.
11. You will be notified two weeks prior to the City's Bluegrass Festival celebration that you need to move out for that time frame or if you are willing to pay the Bluegrass Festival fees, you may continue to stay in your space. We have to know your decision with plenty of time so that your space is not rented out.
12. If after 3 days, monthly rent has not been paid, the electricity will be disconnected and the electrical box will be padlocked.

Any RV left for an extended period of two weeks without prepayment to the city will be towed from the RV Park at the owner's expense.

The City of Overton reserves the right to not accept further rent from any person who fails to comply with these rules and regulations and/or falsification of application will be requested to vacate their RV space immediately. There will be no pro-rated refund.

Reminder: The City of Overton RV park spaces are rented out for seasonal recreational (three months) purposes only and are not intended for year round occupancy.

(Exceptions: persons working temporary jobs such as landmen, pipeline workers, construction, refinery, vacationers or persons who rent or own a permanent residence elsewhere.)
