Failure to prevent an unauthorized discharge of wastewater into or adjacent to waters of the state. Specifically, a manhole located at 32.279189, -94.990384 has been damaged and has discharged.

a. According to the Texas Water Code, 26.121, (a) except as authorized by the commission, no person may discharge sewage, municipal waste, recreational waste, agricultural waste, or industrial waste into or adjacent to any water in the state and (c) no person may cause, suffer, allow, or permit the discharge of any waste or the performance of any activity in violation of this chapter or of any permit or order of the commission.

Resolution: On 6/27/2024 Mr. Johnnie Sawyer, Operator called the TCEQ Tyler Region 5 office to inform that the manhole and surrounding area has been cleaned and disinfected with HTH. He also stated that plans were in place to repair the manhole with a three foot tall riser. This will help prevent future discharges during rain events.
